• Barb Singleton, a retired Halton Secondary School Principal, sent an email heralding the Holiday Season Lights display at their Stone House on Guelph Line just south of Campbellville. Many retired teachers have a sense of community. Some go miles out of their way to help those less fortunate and in need. Barb and her husband Dr. Paul (also a former Halton administrator) do just that. A Tribute To Ethel Gardiner

My dear friend and colleague, Ethel Gardiner, passed away on June 5th after a courageous year-long battle with cancer. On June 9th, a celebration of her life was held at St. John's United Church in Georgetown. It was standing room only as educators from across the province gathered to pay their respects.

Ethel's influence in education began long before her election as a trust-ee representing Halton Hills. It began in 1956 in New Brunswick where she taught Grades 7-12 English and Physical Education. Three years later she was teaching in Copper Cliff, Ontario. By 1967, she was principal and teacher at Milton Heights. She also taught in other Halton schools including Kennedy, Chapel Street, Robert Little, and Centennial.



Ethel retired in June 1995, and successfully ran for trustee (Halton Hills) in October 1995. She was appointed Chair of the Halton DSB in December, 1997 and served until 2003. That year she was acclaimed once again and served her fourth consecutive term as trustee. In 2004, she was the recipient of the prestigious provincial Dr. Harry Paikin award of Merit as well as the Halton District School Board Award of Excellence for her contributions to education in Halton and in Ontario.

Ethel and I were trustees together during the Harris government - not an easy time to be involved in any aspect of education in this province. As a trustee and chair, Ethel was quick to herald the accomplishments of students, educators and support staff, and often did so in a public forum, further promoting the successes of public education. She met each task in a fair and equitable manner, and sought relevant information in order to make informed decisions for the betterment of students and staff of the Halton DSB, and for public education as a whole. As Chair, Ethelbroughtleadership and vision to the board of trustees in Halton, pioneering change and focussing outcomes on student achievement. She was quick to speak out on behalf of public education both locally and provincially. Her passion for people was accented by other pursuits in her life - committeent to family, volunteer participation on a number of community (A Tribute... continues on Page 14)

Changes To RTO/ERO Health Plan

The following is a brief summary of the changes that have been made to the Health Plan effective January 1, 2008:

- The monthly premium rates for benefits have been increased by 0% for Semi-Private Hospital, 2% for Extended Health Care and 3% for Dental. The premium increases are required for expected inflation and utilization.
- The annual prescription drug maximum is increased to \$2,100.
- Dental claims will be reimbursed based on the 2008 Fee Guide for Dental General Practitioners.
- Dental services performed by a dental hygienist (accredited by the College Dental Hygienists of Ontario), independent of a dentist, are a covered benefit.
- The post-surgical eyeglass restriction for laser eye surgery is removed.
- The annual prescription drug maximum for erectile dysfunction medications is increased to \$350.
- The Semi-Private Hospital room reimbursement level is increased to 90% with an unlimited maximum.
- The annual maximum for surgical support stockings is increased to \$300.
- The Extended Health Care Plan's definition of Out-of-Province/Canada "Sudden and Unforeseen Medical Stability Clause" has been revised to include the following parameters which are not insurable:
- 1. Any cancer, heart or lung condition for which, in the 90 days prior to date of departure (or date of booking for the purpose of Trip Cancellation);
- 2. You were awaiting the outcome of medical tests (except routine monitoring), the results of which show any irregularities, or abnormalities;
 - Except routine monitoring, you require future investigation, consultation with any physician, treatment or surgery recommended by your physician or planned before your trip.
 - Any condition for which you are admitted to hospital for a period of at least 24 hours in the 90 days prior to the date of departure (or date of booking for the purpose of Trip Cancellation).
- 3. Any condition for which you have been advised by a physician not to travel.



Pension Committee

I receive telephone calls and emails on personal pension matters. Enquiries are on topics such as applying for a spousal pension on the death of a member or applying for a teacher pension after a number of years outside of the teaching profession. Questions are asked about the effects (benefits and/or problems) on a teacher's pension

if one takes the Canada Pension Plan (C.P.P.) at 60 years of age. However, since matters on an individual's Teachers Pension are resolved by the Ontario Teachers Plan, I would recommend that the individual contact the Pension Plan directly at 1-800-668-0105 (www.otpp.com). I will be happy to answer general questions on teachers' pensions.

Fact Sheets: The Provincial Pension and Retirement Concerns Committee has developed over 60 fact sheets that should be of interest to retired teachers. A new Fact Sheet on Home Security is now available on the RTO/ERO website (www.rto/ero.org) in the members only file. A Fact Sheet index and individual fact sheets can be obtained from the website. Hard copies can be obtained from Liz Timms at the RTO/ERO office, 1-800-361-9888.

The Safe Living Guide: A guide to home safety for seniors is available from the Public Health Agency of Canada. Read it online or download it at www.phac-aspc.gc.ca/seniors-aines/pubs/safelive/slg05_e.htm . This site even lets you read the text in a large font size.

initiatives and committees, and a quest for life-long learning in education. Ethel's advocacy and support for students and staff transcended the boundaries of the Board Room. Political Action Committee

Provincial RTO/ERO is supporting two initiatives of interest to members. The first is the **Coalition After Property Tax Reform** that recommends a revision to the 4-year assessment cycle recently introduced by the Provincial Government. Instead, the Coalition suggests that there be a cap of 5% per year placed on any property tax increases and that subsequent phase-in be put in place by the gov-

ernment. This change would effect an equitable property tax regime for all Ontario property owners.

The second initiative concerns the Provincial Political Action Committee's support for the Health Services and Insurance Committee in its effort to lobby the Provincial Government to have PET scans made available in Ontario as they are in other parts of Canada.

PET (Position Emission Tomography) scans work by injecting a patient with a short-lived radioactive tracer isotope. Cancer cells absorb the glucose more readily than healthy tissue, causing it to light up on a scan. This helps in diagnosing cancers often before they can be found by other methods. It can find a lung cancer that has spread, preventing a futile operation. A lymphoma patient may learn that a worrisome lump is merely scar tissue. Colorectal cancer patients may discover that the tumors on their liver can be safely removed. A scan can help determine when chemotherapy is not working, prompting doctors to change to a drug cocktail. For certain kinds of cancer, the PET can be more revealing than the CT scan. In 20%-40% of cases, cancer patients will have their treatment plan changed based on PET scan results. Everywhere else in Canada, it has become a routine test. Ontario remains the only part of the Organization for Economic Co-operation and Development (OECD) that does not have routine access to PET services.

RTO/ERO will also be closely monitoring Long Term Care, LHINs and other health issues that are important to our members.

Why Join RTO/ERO?

The best organizational friend a retired teacher can have is RTO/ERO. For 39 years it has been the official voice of retired educators promoting and protecting their interests particularly in the areas of pensions, health care and insurance. Tell this to your retired colleagues who are not yet members. Encourage them to join!

District 15 – Halton Membership Survey Results

The September mailing sent to all members of District 15 included a Membership Survey you were asked to complete. A total of 240 surveys were completed and returned (a 12% response rate) – 140 by mail and 100 were completed online. Thanks to those who submitted a response. The following is a brief summary of results. The complete report will be presented to the Executive and the Board in January. The figures shown below are given as a percentage of those who responded to each question.

- 80% join RTO/ERO for the Health Plan and because of Pension related issues. Others like the idea of keeping in touch with former colleagues, the travel and social/recreational opportunities.
- 2% work full-time while 20% work part-time.
- 20% provide daily care or supervision of a parent, spouse/partner, child or grandchild.
- 65% indicated they provide volunteer services to charitable or community organizations. Most devote up to 5 hours per week although there were some who spent more than 10 hours per week.
- 83% indicated that they were aware of the services provided by the District
 15 Goodwill, Political Action and Service to Others committees.
- \bullet 57% indicated they had attended a District 15 function during the past two years, more than half of these attended during the past year. Theatre and day trips were the most popular events .
- Everyone who answered indicated an awareness of the extended travel opportunities provided by the Travel Committee. 21% had taken advantage of one or more of these trips and the satisfaction rating was very high.
- 85% indicated they had access to the Internet. 60% had viewed the District 15 website on at least one occasion during the past year with the vast majority of these viewing it several times per year. Two-thirds of these found the information useful. 40% had never viewed the website.
- Most people who received email communiques from District 15 found them useful.
- 90 % find the information in the Halton Herald useful; 75% read it cover-to-cover, 23% skim through it and 2% do not read it at all. The most interesting aspects seem to be the articles about the life and interests of individual members and the Book of Remembrance.

RTO/ERO has a **Long Term Care Plan** administered by Johnson Inc. that helps cover the cost for chronic illness or disability if you are unable to care for yourself for an extended period of time either in your own home or in a nursing home. This is above and beyond the care offered by the Community Care Access Centres. You can apply at anytime up to age 89 by completing the "Application For

woman, for she'd only get married anyway! Each Sunday night she rode the Lake Erie and Northern electric railway to Hamilton and returned home to Brantford for the weekend.

Mary's career began in a one-room school in Waterloo County at 19. Two years later, she moved to another one-room school in the village of Roseville. She took a year's leave from teaching to attend McMaster University to get her permanent teaching certificate. While teaching at Tuck's School on Hwy 5, she met George Rose. On July 1, 1939 they were married in her parents' home. Her mother made her wedding dress and she remembers throwing her bouquet out the upstairs window. They lived on a 50-acre fruit farm on Brant Street between Plains Road and Hwy 5, later on Kerns Road. When George died in 1991, Mary found living in the house alone unsettling and so she moved to a more central, attractive apartment on Lakeshore Road.

The Roses had two children - Agnes and George. Agnes, who lives in Ottawa, comes to stay with Mary once a month. George lives in Brantford where he leads the well-known George Rose Band. His wife Mary Ann and their 3 children are all musicians. In 2005, George and the family with Mary at the piano, performed in the Brantford Kiwanis Music Festival. Mary showed me a letter from the festival adjudicator who wrote, "These (i.e. families making music together) are the things that build magical memories for a lifetime." Mary is deservedly proud of her children and their families. She shared a collection of photos, letters, wills, family stories and family trees with me which she has spent hours compiling as a unique legacy for her family.

Working mothers were not the norm when Mary was raising her children so it was 11 years before she picked up her career again. She taught at Glenwood, Mountain Gardens and Elizabeth Gardens. She enjoyed teaching music and often helped colleagues by teaching their music classes too. She's always loved books, so it comes as no surprise that she trained to be a librarian assuming a part-time librarian's position at Kilbride and then fulltime at Mohawk Gardens. In all of her 31 years of teaching, introducing children to the wonderful worlds between the covers of books gave Mary the greatest pleasure.

When she retired, Mary joined the Burlington Retired Women Teachers and served in several capacities, including President. She has kept her interest in the world around her. She used to travel widely on this continent and abroad. Now, beside her chair sits a tall pile of library books which Agnes brings for her. 



